Manufacturer's Certification Statement related to Revere Vinyl Window and Patio Door Products that may qualify as energy efficient as part of the Non-Business Energy Property Tax Credit.

Revere, headquartered at 3773 State Road, Cuyahoga Falls, OH 44223, manufactures exterior window and patio door products. These products carry U-Factor and SHGC (Solar Heat Gain Coefficient) performance ratings certified by the National Fenestration Rating Council. ENERGY STAR® qualified windows and patio doors meet or exceed the criteria established by the U.S. Department of Energy for each of the climate zones.

Information on how to determine the U.S. climate zone where you live can be found at http://www.energystar.gov/index.cfm?fuseaction=windows_doors.search_climate. To determine if your purchased window(s) meet the qualifying requirements for your climate zone, refer to the NFRC sticker on your window(s) or visit www.reverewindows.net to lookup the performance ratings for the specific model and glass pack combination. Qualifications vary by model and ENERGY STAR climate zone.

Qualifying products meet the requirements for the Non-Business Energy Property Tax Credit that has been extended from 12/31/2017 through 12/31/2020. Products purchased must be for an existing home and your principal residence. Please note, neither the ENERGY STAR program nor the U.S. EPA has any role in setting, implementing or managing the Federal Tax Credits. Federal Tax Credit amounts are set by the U.S. Congress and are managed by the IRS, which offers a toll-free assistance hotline at 1.800.829.1040. This Certificate is intended to show that Revere Window and Patio Door products are eligible building envelope components. Homeowners should consult with their tax advisor to determine whether they qualify for any potential income tax credits.

To file for an energy efficiency tax credit, you must file the IRS Tax Form 5695 and submit with your taxes. You will also need to save your receipts and this Manufacturer's Certification Statement for your records. You cannot claim the energy efficiency tax credits by filing either the 1040EZ form or 1040A form. To receive the tax credit, you will need to file a 1040 tax form. If you have already filed your return, you will need to file an amended return (Form 1040X) to claim these credits. See the IRS Tax Form 5696 Instructions for more information.
